#### **Hospital Liaison Report**

Mike Rosenbalm - Hospital Liaison

Over the years I have found many veterans' are not aware of Hospital Indemnity Insurance. Several of these veterans' told me that they wished they had previously known about and purchased this type of insurance that they would have benefited from the cash benefit it pays. Therefore, I am writing this article for informational purposes to increase awareness, not as an endorsement.

#### What is Hospital Indemnity Insurance?

Hospital indemnity insurance provides the policy holder/insured with a fixed or variable cash benefit for their hospitalization. The benefit amount of cash and how it is paid out depends on the hospital indemnity policy. In addition, many policies pay

a greater amount per day if you are hospitalized in intensive care or for cancer treatment.

#### **Fixed Rate Hospital Indemnity Insurance**

Fixed amount policies pay a fixed amount for each day such as \$100 per day. (Amount will vary based on policy.)

#### Variable Rate Hospital **Indemnity Insurance**

Variable amount policies pay variable amount such as \$250 day 1; \$100 day 2 through 30; \$150 day 30-60, \$300 day 61 and beyond. (Amount will vary based on policy.)



## VA Provides My Care for Free or Minimal Co-Pay

Since many veterans' receive free or low cost care from the VA they often discount potential benefits and do not consider purchasing hospital indemnity insurance marketed to help insured by paying them cash to offset deductibles, coinsurance payments and expenses related to being hospitalized.

While it is true veterans receive free or low cost care from the VA and may not have these costs when hospitalized. Many veterans must pay their own travel and lodging expenses to get to and from the VA. Veterans in receipt of Aid and Attendant (A&A) allowance, including that payable under 38 U.S.C. 1114(r)(2), are subject to reduction under 38 CFR 3.552(b)(2).

"When a veteran is hospitalized at the expense of the United States Government, the additional aid and attendance allowance authorized by 38 U.S.C. 1114(r) (1) or (2) will be discontinued effective the last day of the month following the month in which the veteran is admitted for hospitalization."

Therefore, while the veteran receives free care from the VA he/she can have costs associated with hospitalization including loss of their A&A benefit they many depend on.

Example: service connected veteran has skin break down that requires a 105 day hospital stay March 15 through June 30, The veteran can lose Aid and Attendant pay on April 30th resulting in the loss of approximately 4,000-6,000 dollars. If this veteran had Hospital Indemnity Insurance at the \$100 daily rate they would be entitled to a claim of \$10,500 (105 days hospital times \$100 per day). This would offset the loss of Aid and Attendant pay lost due to hospitalization.

# Features to Consider When Looking For Hospital Indemnity Insurance

Consider the following when comparing policies

- Amount of daily payment. Some policies provide for increase in coverage for a stay in a hospital Intensive Care Unit and/or cancer diagnosis.
- Whether the amount of payment is unconditional, or conditioned on other insurance you have.
- How long the benefit is payable. Some policies have a limit of 60, 180, 365 days and etc.
- Eligibility (What if any eligibility restrictions are there)
- Who receives the money? Most policies pay you, but a few pay the hospital.
- Pre-existing condition exclusion. Many policies have a 6 or 12 month pre-existing condition exclusion.
- When payment starts. Most policies start payment on the first day of hospitalization, but others doesn't start until being hospitalized for 3 days, 1 week and etc.
- Termination: Some policies terminate or reduce benefits at age 65
- Some policies are for illness and others accident

Hospital indemnity policies frequently are available directly from insurance companies by mail as well as through insurance agents. You will find that these policies offer many options on benefits and terms, so be sure to ask questions and find the right plan to meet your needs.

If you Google the term "Hospital Indemnity Insurance" you will find numerous companies and organizations ranging from Allstate, State Farm And Physicians Mutual to AARP that offer hospital indemnity insurance.



#### **Filing Claims**

Most insurance companies require you complete a claim form online or by mail. Benefits will be paid shortly, as long as you meet eligibility requirements.

#### **Summary**

Hospital indemnity insurance provides cash benefits for each day you are hospitalized. When you're in the hospital, the last thing you need is to worry about money. With a Hospital Indemnity Insurance policy, you can concentrate on getting well. The cash benefits are typically paid directly to you not the VA or doctor. So it's your money to spend as you see fit.


Also I am putting a bowling team together, just to start, let's get together and do some bowling as a group and go from there, if anyone has any ideas that may help me out with this process please give me a call.

I recently had the opportunity to attend the 36th National Veterans Wheelchair Games in Salt Lake City, thanks to the Paralyzed Veterans of America, Oregon chapter. I enrolled in 5 events. Slalom, Field events. Archery, Softball, and Basketball.

My week started out on Monday the 27th of June participating in the Media Kickoff basketball game. The city turned out to cheer us on and the games were underway.

Tuesday the 28th marked the first day of competition and I was opening with an 8 a.m. basketball game. It turned out to be the game of the tournament as we fell in the final seconds when Team White laid the ball up for the 2 point victory. My team pushed on and finished up by winning the next three games to take home the bronze.

Softball filled up my evenings and what a great team I was allowed to play with. On the opening night we overcame a 9-4 deficit with a 10 run rally in the 7th inning. We eventually played in the championship game but came up one rally short, losing 6-3.

Shot put, Javelin, and Discus were nice to me netting gold-silver-gold respectively. After a scratch in the Slalom I was able to put up a PR in archery with a 632/720 for gold.

I think the best time for me was on HP kids day. It is a day where local children with disabilities are invited out to come participate in some of the events that are held.

This year we had a strong turnout of 16 children. 18 Wheelchair Games competitors were selected as mentors and guided the youth through Basketball, Slalom, and Softball.

By the end of the hour there were smiles on everyone's faces and I'm guessing they stayed for hours like mine.

My week at the VA and PVA hosted games ended with a very special award. I was selected as the 36th NVWG Spirit of the Games recipient, which caught me by surprise.



The games for me are an opportunity to see old friends but foremost to reach out to the new faces and do everything we can to make their experience everlasting.

To be recognized by my peers was such an honor but more it is a reflection of the rehabilitation that I was afforded in a VA Hospital in Seattle, WA. Since I was left speechless on the evening the award was presented I would like to say a few things I missed.

"Part of the rehabilitation process is making a difference in someone else's life"

A thousand thank yous go out to my team that helped me rehabilitate back in 1999.




# Greetings from the Development Department

One might think that hunting is exciting all of the time but the truth is it is work that is why they call it "HUNTING". The Experience of a lifetime continues

All of a sudden Chuck slammed on the brakes and said the magic word. "DEER!" I have not been out in the woods since I was a teenager and my first response was, "WHERE?"

Chuck spent the next few minutes trying to show me where it was. Finally he got out of the truck and came over to my window and aimed the rifle with a 3X9 Leupold scope. Then I could see the deer (200 yards) looking back at us. Hopefully my skill in being able to locate game has improved since that incident.

Later on that season we were scoping the hillside across the canyon. It was the last day we were going to shoot an Elk if we saw one. The hillside that we were looking at was very visible from our vantage point but not to those of our huntin' party who were located on the road below.

Chuck spotted two bull elk moving up a trail and he took a shot. The elk stopped and the next shot hit just below them. That made them move different directions. This is where ethics come into play. At that range he was not sure he hit the Bull Elk or not so we had to go check.

The ride from one side of the canyon to the other was the first time I experienced Chuck's wild and crazy driving. Yes, everything was totally under control but quite breathtaking.

We had to travel about one mile then head downhill to a gate. We then went down one more set of steep downhill roads at 60 MPH when all of a sudden Chuck slammed on the brakes. When we finally stopped skidding he looked at me and asked if he was scaring me. I honestly but sheepishly said, "No." He resumed careening down the gravel road.

When we reached the bottom I breathed a sigh of relief then we started up the other side. It was tolerable until we reached the level part of the road when our speed increased substantially. 





#### **National Director Report**

Bill Gray - National Director

Fellow Veterans we are all getting a little older I thought that many of you would enjoy knowing about what you're Burial allowances are and how to take advantage of them.

#### WHAT ARE VA BURIAL **ALLOWANCES?**

VA burial allowances are flat rate monetary benefits that are generally paid at the maximum amount authorized by law for an eligible Veteran's burial and funeral costs. A VA regulation change in 2014 simplified the program to pay eligible survivors quickly and efficiently. Eligible surviving spouses of record are paid automatically upon notification of a Veteran's death, without the need to submit a claim. VA may grant additional benefits, including the plot or internment allowance and transportation allowance, if it receives a claim for these benefits.

#### WHO IS ELIGIBLE?

If the burial benefit has not been automatically paid to the surviving spouse, VA will pay the first living person to file a claim of those listed below:

- The Veteran's surviving spouse, or
- The survivor of a legal union\* between the deceased Veteran and the survivor, or
- The Veteran's children, regardless
- The Veteran's parents or surviving parent, or
- The executor or administrator of the estate of the deceased Veteran

\*Legal union means a formal relationship between the decedent and the survivor existed on the date of the Veteran's death, which was recognized under the law of the State in which the couple formalized the relationship and evidenced by the State's issuance of documentation memorializing the relationship.

## The Veteran must have been discharged under conditions other than dishonorable

In addition, at least one of the following conditions must be met:

- The Veteran died as a result of a serviceconnected disability, or
- The Veteran was receiving VA pension or compensation at the time of death, or
- The Veteran was entitled to receive VA pension or compensation, but decided to receive his or her full military retirement or disability pay, or
- The Veteran died while hospitalized by VA, or while receiving care under VA contract at a non-VA facility, or
- The Veteran died while traveling under proper authorization and at VA expense to, or from, a specified place for the purpose of examination, treatment, or care, or
- The Veteran had an original or reopened claim for VA compensation or pension pending at the time of death and would have been entitled to benefits from a date prior to the date of death, or
- Disabilities determined by VA to be related to your military service can lead to monthly nontaxable compensation, enrollment in the VA health care system, a 10-point hiring preference for federal employment and other important benefits. Ask your VA representative or Veterans Service Organization representative about Disability Compensation, Pension, Health Care, Caregiver Program, Career Services, Educational Assistance, Home Loan Guaranty, Insurance and/or Dependents and Survivors' Benefits. or
- The Veteran died on, or after, October 9, 1996, while a patient at a VA-approved state nursing home.

#### **HOW MUCH DOES VA PAY?**

#### **Service - Connected Death**

If the Veteran died on or after September 11, 2001, the maximum service-connected burial allowance is \$2,000. If the Veteran died before September 11, 2001, the maximum service-connected burial allowance is \$1,500. If the Veteran is buried in a VA national cemetery, VA may reimburse some or all of the costs of transporting the deceased Veteran's remains.

#### Non Service - Connected Death

If the Veteran died on or after October 1, 2015, VA will pay a \$300 burial allowance and \$747 for a plot.

- If the Veteran died on or after October 1, 2014, but before October 1, 2015,
- VA will pay \$300 for burial allowance and \$745 for a plot.
- If the Veteran died on or after October 1, 2013, but before October 1, 2014, VA will pay \$300 burial allowance and \$734 for a plot.
- Effective October 1, 2011, there are higher nonservice-connected death rates payable if the Veteran was hospitalized by VA at the time of his or her death.
- If the Veteran died on or after October 1, 2015, VA will pay a \$747 burial allowance and \$747 for a plot.
- If the Veteran died on or after October 1, 2014, but before October 1, 2015, VA will pay a \$745 burial allowance and \$745 for a plot.
- If the Veteran died on or after October 1, 2013, but Before October 1, 2014, VA will pay a \$734 burial allowance and \$734 for a plot.

If the death occurred while the Veteran was properly hospitalized by VA, or under VA contracted nursing home care, some or all of the costs for transporting the Veteran's remains may be reimbursed.

Note: If the Veteran dies while traveling at VA expense for the purpose of examination, treatment, or care, VA will pay burial and plot allowances and transportation expenses.

#### **Unclaimed Remains**

If a Veteran dies and their remains are unclaimed, the entity responsible for the burial of the Veteran would be entitled to a \$300 burial allowance. If the Veteran is buried in a VA national cemetery, VA may reimburse the cost of transporting the deceased Veterans remains. VA may also reimburse for the cost of a plot.

#### **HOW CAN YOU APPLY?**

You can apply by completing

#### VA Form 21P-530

Application for Burial Benefits. You should attach a copy of the Veteran's military discharge document

(DD Form 214 or equivalent) and a death certificate. If you are claiming transportation expenses, please attach a receipt for the expenses paid.

You can call us toll-free within the U.S. by dialing 1-800-827-1000. If you are located in the local dialing area of a VA regional office, you can also call by checking your local telephone directory. For the hearing impaired, the TDD number is 711.

You should mail your application to the VA regional office located in your state. You can obtain the mailing address for VA regional offices by accessing the locations site. The address is also located in the government pages of your telephone book under "United States Government, Veterans."

#### **Answer These Questions Before a Disaster**

Daniel Service - Treasurer

During an emergency you'll need immediate answers to many question. Here are some questions you should answer long before a disaster strikes.

#### Where will my family be and how will I reach them?

- Make sure your family disaster plan includes:
  - Children who may be away at school, day care, or at other activities.
  - Planning for pets or livestock if you are away from home.
  - An out-of-the area contact to convey information to other friends and family members.
- Discuss your safety and emergency plans with everyone in your family.

Remember - The 9-1-1 system will likely be overloaded or completely down, ambulances and emergency vehicles will be overwhelmed or have limited access and some medical facilities may not be operational.

#### Am I prepared to live without the essentials?

- Store water at home, work and in your car because drinking water will be in short supply.
- Keep at least one week's worth of food and medicine on hand for everyone in your family.
- Fill up your gas tank frequently and keep it at least half full because gasoline will be scarce.

Remember – Utilities and water supplies may be disrupted for weeks.

#### How will I pay for thing?

Keep cash on hand because banks may be closed and credit cards unusable.

Remember - ATM's are likely to be out of order.

#### How will I repair the damage to my home?

- Examine what your insurance covers and consider earthquake and/or flood insurance.
- Minimize losses by taking action to reduce your hazards.

Remember – Construction materials and labor for repairs will be limited and costs may increase.

### Do I live, work or visit in a tsunami hazard zone?

- If you are in a tsunami hazard area, determine your evacuation routes beforehand you may only have 10 to 20 minutes to reach a save zone on foot after feeling a very strong earthquake at the coast.
- If you are in a safe area, typically above 100 feet above sea level, stay put. You will not have to evacuate.

Remember – there will be no time for an official tsunami warning to reach you if the ground shakes and you are at the coast.

#### Who's going to save you?

Who can you rely on to help you after a disaster? Who will provide you with food, water, shelter, and medical care? You might be surprised by the answer: you and your neighbors!

A major earthquake or tsunami will likely overwhelm local law enforcement, fire, and emergency medical personnel and resources. In fact, it may take local, state and federal agencies a week or more to provide the most basic relief. This is particularly true in the many locations on the coast and in rural areas of Oregon.

Getting prepared today by identifying and mitigating hazards, readying supplies, and developing an emergency plan may make all the difference to you and your family during a disaster.

## **Presidential Campaigns Wrap-up Nominating Conventions**

The House and Senate recessed in mid-July to accommodate the Republican and Democratic National Conventions held over the last two weeks of July. The Republican National Convention (RNC) was held the first week after recess in Cleveland, OH. During the convention, Donald Trump and Mike Pence were formally nominated as the Republican candidates for the President and Vice President. The Democratic National Convention (DNC) was held the following week in Philadelphia, PA. During the DNC, Hillary Clinton and Senator Tim Kaine were formally nominated as the Democratic candidates for President and Vice President.

The conventions also included approval of the official party platforms for the Republican and Democratic parties. Both platforms recommit to America's sacred trust to veterans, they expound at length the heroic character of our service members, and regrettable consequences that befall them and their families. Where their similarities diverge is in each party's perception of primary problems and the corresponding plans to address them. The full RNC platform can be accessed at: https://gop.com/platform/. The RNC platform denounces the wait-time

scandals concerning VA. In response to these controversies, Republicans seek accountability of senior leadership and fundamental changes to their structure. Regarding veterans' health care, Republicans will seek to consolidate VA's existing community care authorities to make a single program. In order to combat bureaucratic stagnancy, they encourage VA partnerships with private enterprises, VSOs and competitive bidding, predicting such work will allow for high quality VA care, reduce backlogs, and save resources. Additionally, Republicans will retain veterans' preference, support a broader range of options for health care, including faithbased programs to respond to the opioid crisis, and encourage private sector and public school hiring of veterans.

The Democrats. equally enraged by VA scandals, propose fully resourcing VA to meet the needs of all veterans and reject attempts at privatization. The platform emphasizes the need for more education benefits and job training, preservation of the post-9/11 GI Bill, and fair treatment of reservists and Guard members. They recommit to ending chronic homelessness and suicide. Regarding veterans' health care, they emphasize veteran-centric care, resources for military sexual trauma (MST), the growth of mental health programs, treatment of invisible and toxic wounds and the expansion of the VA Caregiver Program to veterans of all eras. They seek to provide women with full and

equal treatment, including reproductive health services. The DNC platform also proposes workplace policies that are more equitable for caregivers, as well as the expansion of a well-paid home care workforce and increased access to long-term care. They disfavor the deportation of immigrants who are veterans, while also highlighting the housing crisis for veterans in Indian Country.

The only identical policy proposal from both parties, aside from vaguely ensuring high quality health care and benefits for veterans (achieved differently), is a commitment to veterans treatment courts to prioritize rehabilitation over incarceration.

The respective platforms also offer views on some disability policy, albeit with slightly different inflections. The Republican platform highlighted the GOP's historic support of the Americans with Disabilities Act (ADA) and the role of Republican leadership in the enactment of the Workforce Innovation and Opportunity Act (WIOA), ABLE Act and the Steve Gleason Act. WIOA was the first major overhaul of the nation's workforce system in almost 20 years while the ABLE Act was a measure that lets people with disabilities maintain access to services while saving to develop assets. Gleason law bears the name of former NFL player Steve Gleason who developed ALS. The law provides access to speech-generating devices. To encourage entrepreneurship, the platform endorsed opening the Small Business Administration's 8(a) certification program to people with disabilities, something that PVA has long supported. The platform continued the party's opposition to embryonic stem cell research and the Convention on the Rights of Persons with Disabilities. Social Security was addressed largely from the perspective of reforms needed to the retirement system with Republicans calling for "all options," other than tax increases, to be considered for modernizing this important social insurance program.

The Democratic platform addressed a number of

issues important to individuals with disabilities including affirmation of support for the ADA and promises to expand access to appropriate accommodations and supports people with disabilities need to live in integrated community settings. The party endorsed policies that would bring to an end sub-minimum wage work, improve the lives of caregivers of people with disabilities, increase federal funding for affordable housing for low-income families, people with disabilities, veterans and the elderly, improve access to meaningful and gainful employment for people with disabilities and vowed to continue to fight for ratification of the Convention on the Rights of Persons with Disabilities.

In sections of the platform concerning restoration of the full protections of the Voting Rights Act (VRA), the Democrats highlight support for full funding of the Help America Vote Act (HAVA) to ensure that all registration materials, voting materials, polling places, and voting machines are fully accessible to seniors and Americans with disabilities. With regard to Social Security, the platform opposes efforts to cut or privatize the program or raise the retirement age and supports improvements to the cost-of-living formula that better reflects the fixed expenses of seniors and people with disabilities. The party also proposes measures to ensure the long term solvency of Social Security by asking those earning above \$250,000, a year to contribute more to the system and to provide sufficient financial support to the Social Security Administration to ensure it can provide timely benefits and high quality services to all beneficiaries.

Ultimately, the platforms only serve as a guide for the two parties during the course of the political campaigns with the goal to influence the policy positions of the major party candidates. However, the presidential candidates are not obligated to adopt the platform proposals. During next month's Washington Update, we will highlight the individual candidates' policies directed towards veterans and people with disabilities.

#### **PVA Attends VA Joint Symposium:** Safeguarding the Integrity of GI Bill **Benefits**

On August 3, 2016, VA and the Deputy Under Secretary for Economic Opportunity, Curtis Coy, hosted a joint symposium to address VA's enforcement of its consumer protection authorities to protect veterans from dishonest schools. VA has faced considerable criticism for failing to take action against predatory for-profit colleges targeting veterans and service members. Current law calls for VA to cease distribution of federal funds when it finds that a school is employing aggressive, deceptive or fraudulent recruiting practices in order to get access to the lucrative GI Bill and Defense Department Tuition Assistance. So far, however, VA has taken relatively few enforcement steps despite numerous reports of deceptive behavior.

PVA and its VSO partners discussed the various legal authorities VA has at its disposal and advocated for greater enforcement efforts against such schools. We also encouraged VA to develop a support structure for veterans who have already been harmed by these schools or are otherwise forced to try and transfer into a different school to continue their education.

#### **PVA Conducts Survey to Support Access Committee Work**

In May, PVA was notified that Lee Page, Senior Associate Advocacy Director, was selected to be a member of the Access Advisory Committee on Accessible Air Transportation overseen by the Department of Transportation (DOT). The Committee is comprised of representatives from the disability community as well as the airline industry. During its first meeting, the ACCESS Committee selected PVA to chair the workgroup evaluating the need for accessible lavatories on board aircraft.

In order to assist the ACCESS Committee, PVA recently conducted a survey/poll to disability stakeholders addressing seven questions that gauge their expectations for an accessible lavatory on a new single aisle aircraft. The poll was conducted over a three week period, with final results being collected on August 1, 2016. During that time period, 931 total respondents and 515 PVA members registered their opinions. We were particularly pleased with the response rate—8 percent—to the survey (industry standards consider 3 percent response rate to any survey to be good).

The overall results show that current lavatories are too small and more space is needed. The other significant take away was the lack of ability to get to the lavatory. Many respondents indicated that they were not aware of on board wheelchairs and had trouble getting the assistance needed to obtain them or their personal assistive devices. Additionally, airline personnel need more training in order to assist passengers throughout the process.

#### Review of AirAccess30.org Website

With the www.AirAccess30.org website now having been live for six months, we have analyzed visitor traffic on the site. In the first six months, there have been approximately 3,200 total visits to the website and approximately 2,700, unique visits. While visits to the website decreased during April and May, there was a significant increase in June and July. Some of this can be attributed to more awareness from PVA members as they traveled to our Annual Convention in May and to the significant number of athletes who traveled to the National Veterans' Wheelchair Games in June and July. Additionally, the time spent on the website during each visit increased significantly during June and July. The website currently includes 39 individual stories with additional stories that will be posted soon. We will continue to promote the website widely leading up to the

30th anniversary of the Air Carrier Access Act signing in October and carrying into the newCongress next year.

## **Election Assistance Commission Focused on Security for Elections**

The U.S. Election Assistance Commission (EAC) was established by the Help America Vote Act (HAVA) in 2002. The EAC is an independent, bipartisan commission charged with developing guidance to meet HAVA requirements, adopting voluntary voting system guidelines, and serving as a national clearinghouse of information on election administration. The EAC is currently working with all levels of government to facilitate the conversation regarding securing the election process and to support election officials' efforts to provide an accessible and secure voting process.

Since the creation of its Voting System Testing and Certification Program, in partnership with the National Institute of Standards and Technology, the EAC has led in ensuring voting systems brought to the market have been vigorously tested against security standards. Voting systems certified by the EAC are not connected to the Internet.

Further, the EAC has worked with local and state election officials—as well as election stakeholders, from accessibility experts to scientists and academics—to ensure that best practices are shared nationwide. These best practices include pre-election testing, security, continuity planning, and post-election audits. Already this year, the EAC has conducted a

series of events related to the #BeReady16 initiative, and more are underway and planned, including activities addressing Election Security Preparedness.

Voters are encouraged to get involved with their state and local election officials, and ask questions about their election process. The vast majority of election offices offer numerous opportunities for voters to engage in the process, including witnessing pre-election testing of the voting systems. Election officials welcome voters' questions and

participation because they want voters to have confidence and to participate in the process.

The EAC also encourages voters to work at the polls as election workers. The election process benefits from full engagement from all people, and election administrators across the country are seeking election workers now for November. With 50 days before the deadline to mail ballots to military and overseas voters, the EAC is working with all stakeholders to lead discussions productively so that voters can have the utmost confidence in the election process.


