
Dawn is on the City Council for the City of Independence, she was instrumental in making sure that the parade was going to happen this year, she reached out to the chapter office to see if we



# AIR RIFLE/AIR PISTOL DUSTIN SIMMONS

Hello again shooters,

In this update I am happy to announce we are making major progress with getting this program finally up and running. I went with our President Larry Gardner and Executive Director Tom Hurt to the Albany Rifle & Pistol Club. This club is located at 29999 Saddle Butte Rd. Shedd, Oregon. While there we were able to speak with the Executive Director of the club Brian Boesch.



That club has been doing extensive work making it wheelchair accessible.

They have an indoor range for 22 and .177 caliber air rifles. This building is heated for winter months and while we're getting this program off the ground, it will be free for our practices.



They are willing to let us use the clubhouse attached to that indoor shooting range as a place we can eat lunch, relax, and chat. They are excited to work with us veterans and are willing to step in and help us wherever we may need the assistance.

By the time you are reading this article we will have received our spring stand tripods. Next, we will be developing the platforms needed to work in conjunction with the shooting lanes with inside the range.



I really hope this location will be suitable for all or most of our shooters. We were trying to find something centralized, an indoor range, accessible, and with it being free for our initial uses, you really can't get much better than that.

We are going to be working on getting a few of our members to be qualified in giving proper instruction in order to help teach anybody interested the technicalities involved with air rifle shooting.

If possible, with the people interested we could even get a team together and developed. Then if our members/ team is interested, we could go into competition against other teams and possibly even other chapters.

For some this sport is a great way to continue their shooting without having to destroy their shoulders from the recoil of other rifles or shotguns. As mentioned in prior articles we are setting this up with National Veterans conform Wheelchair Games standards so that it is an easy crossover. I believe that by doing this, those who are interested in excelling can also qualify for the Paralympic venue. I'm looking forward to seeing our first open house in the mid to late summer. Until then, stay safe.



## **Memorial Day Tribute**

"In Flanders Fields" is a war poem in the form of a rondeau, written during the First World War by Canadian physician Lieutenant-Colonel John McCrae. He was inspired to write it on May 3, 1915, after presiding over the funeral of friend and fellow soldier Lieutenant Alexis Helmer, who died in the Second Battle of Ypres. According to legend, fellow soldiers retrieved the poem after McCrae, initially dissatisfied with his work, discarded it. "In Flanders Fields" was first published on December 8 of that year in the London magazine Punch. Flanders Fields is a common English name of the World War I battlefields in Belgium and France. It is one of the most quoted poems from the war.

As a result of its immediate popularity, parts of the poem were used in efforts and appeals to recruit soldiers and raise money selling war bonds.

I attended the Memorial Day Tribute at the Roseburg National Cemetery on Memorial Day, there was a great turn out of many induvial and family members as they came to pay their respect to the many fallen hero's that have paid the ultimate price keeping this country free. We posted colors and had a flag line and a three round rifle salute. I just want us all to remember how special it is to live in this great country and the price that's been paid.

## Hospital Liaison Report



### More than 1.28 million Veterans will receive notification of refunds in the coming days

Are you a Veteran wondering if you will receive a refund for copayments made for medical care and pharmacy services you've paid since April 6, 2020?

The American Rescue Plan (ARP), passed in March 2021, included a provision that canceled VA copayments for medical care and pharmacy services received between April 6, 2020, and Sept. 30, 2021. Refunds will be sent to Veterans who paid copayments for health care and pharmacy services received during this period.

On May 12th, VA began mailing letters to each Veteran with information on refunds, timing of when informational patient statements will resume, and when VA will begin normal collection of copayments.

"We want to make sure Veterans who made payments on their account are aware their refund is on its way," said Susan Reed, executive director of Revenue Operations, VHA's Office of Community Care.

"This will provide clarity on what you can expect, and a few other reminders in terms of when you will begin to see monthly statements."



Veterans will not be charged copayments for medical care and pharmacy services received between April 6, 2020, and Sept. 30, 2021.

Monthly statements will resume in July 2021, but the July, August and September statements will be informational only. They will include an insert reminding you that if you have a balance for services received prior to April 6, 2020, you can voluntarily make payments now.

VA will resume normal billing and collections Oct. 1, 2021.

#### **Frequently Asked Questions**

- Why is my copayment balance being canceled? With the passage of the ARP in March 2021, all Veteran copayments for medical care and pharmacy services provided April 6, 2020, through Sept. 30, 2021, are canceled.
- I've been paying on my balance over the last few months. Will I get a refund? When will I receive that refund? Due to the passage of the ARP, Veterans who paid copayments for medical care and pharmacy services provided April 6, 2020, to the present will receive a refund from VA. Payments received after April 30, 2021, will be refunded on a case-by-case basis. Initial refunds will be paid by July 2021. In May, Veterans who are due a refund will receive a letter from VA with the amount of their initial refund. Refunds will be paid in electronic funds transfer or by check, depending on information in the Veteran's profile.
- When will I begin to receive statements again? We will resume mailing patient statements in July 2021. These statements are for information only and Veterans are not required to make payments when they receive these statements. Normal billing will remain suspended until Oct. 1, 2021.
- I think I'm due a refund. Should I call VA to confirm? We kindly ask that you not call to inquire about the quantity or timing of

- your refund at this time. VA staff are working hard to mail notification letters and to ensure refunds are paid. Initial refunds are expected to be paid by July 2021.
- Can I view an old patient statement online? Visit AccessVA at https://eauth. va.gov/accessva/ to view patient statements online.
- I had collection actions taken prior to when statements stopped in April 2020. Will those go away? All collection actions have been suspended since April 6, 2020, and will resume Oct. 1, 2021. You will be notified before collection actions resume.



- Can I make payments to the balance I incurred prior to April 6, 2020? Please wait until July 2021 to make payments on balances, so we can ensure copayment cancellations and refunds have been accurately processed. At that time, if you have a copayment balance for care received prior to April 6, 2020, you can voluntarily make payments.
- How do I voluntarily submit payment? Submit your payment by mail. Please include the payment coupon from your patient statement.

  - ♦ Call 888-827-4817. You will need your patient account number.

- ♦ To locate your account number, check your patient statement, call 866-400visit https://eauth.va.gov/ 1238, accessva/?cspSelectFor=vbs.
- I had a balance on my account prior to April 6, 2020. What if I can't pay that balance due to financial matters? VA has expansive debt relief options available:
  - ♦ Suspension of debt: You are not required to pay on your debt until October 2021.
  - ♦ Monthly repayment plan: You can request an agreement to make smaller payments each month to pay your debt over time.
  - ♦ Waiver, write-off, or compromise: If you cannot make monthly payments, you can request a waiver, write-off, or compromise.
  - ◊ Financial hardship determination: If you are struggling because of life circumstances, you can request financial hardship assistance to manage VA debt or an exemption from future copayments.

# PVA Testifying in Congressional Hearing Today!

#### TESTER, MURRAY RAISE CONCERNS OVER VA CAREGIVERS PROGRAM

On May 18, Senate Committee on Veterans' Affairs Committee Chairman Jon Tester (D-MT) and Sen. Patty Murray (D-WA) expressed concerns over VA's tightened eligibility and delayed roll-out of its Caregivers Program.

Congress expanded the Caregivers Program to veterans of all eras under the VA MISSION Act of 2018. Since the law's implementation, VA has reported more than 70,000 applications for the Caregivers Program, 27,000 of which were denied. Data shows that the highest percentage of denials were due to the activity of daily living (ADL) requirement and the 70 percent service-connection requirement. In a letter to

VA Secretary Denis McDonough, the Senators pushed VA to reconsider both the ADL and the 70 percent rule—requirements currently inhibiting caregivers' ability to receive the benefits they deserve.

The Senators also laid out questions regarding denials and appeals for the Caregivers Program, and resources needed by VA to appropriately implement Phase 2 of the program's expansion to provide critical benefits and services to deserving veterans and their caregivers.

# THE ADMINISTRATION'S FY2022 BUDGET PROPOSAL: VA

VA spending could increase by 10 percent over current year levels if the amounts in the President's recent fiscal year (FY) 2022 budget proposal to Congress are adopted. The Administration requested \$269.9 billion for VA in FY 2022 in addition to the \$18 billion proposed by the President's American Jobs Plan (AJP) for VA construction projects. When combined with appropriated funding from the American Rescue Plan (ARP) and available funding from VA's Transformational Fund, the proposal would fully fund veterans' programs, benefits, and services for the for the first time in a generation.

\$117.2 billion of the baseline budget proposal would be classified as discretionary spending used to support VA's health care, benefits, and national cemetery programs. Roughly 86 percent of that amount would go toward the delivery of health care alone. The remaining \$152.7 billion is mandatory spending used to support VA's benefit programs like compensation and pension, readjustment, housing, and insurance programs.

Besides allowing the Department to continue its fight against COVID-19, these amounts would support VA's ability to provide care to seven million veteran patients, continue its electronic health record modernization project, improve facility infrastructure, and make the operation and maintenance of more than 7,300 facilities that VA owns or leases easier. It also enables VA to continue its work to reduce veterans homelessness and suicide and provides more than \$115 billion in advance appropriations for FY 2023 to ensure continuity of health care services into the new fiscal year.

Areas of the President's budget which are of likely of interest to PVA members include the continued expansion of VA's Program of Comprehensive Assistance for Family Caregivers (PCAFC). The proposal raises spending for PCAFC by \$350 million in FY2022 for a total \$1.4 billion. The higher amount supports the inclusion of Phase 1 veterans who are now eligible to participate in the program but will not help PVA's efforts to accelerate the start date of Phase II.

Another area of interest is infrastructure. The budget proposal notes that the average age of U.S. private sector hospitals is 11 years; however, the median age of hospitals in VA's portfolio is 58 years, with 69 percent of VA hospitals over the age of 50. In addition to the \$18 billion from the AJP requested to enhance VA infrastructure, ongoing SCI projects at San Diego, Dallas, and St. Louis have FY 2022 funding requests associated with them which are necessary to keep the larger effort at these sites moving forward.

Finally, the Administration is proposing \$882 million for VA research in FY 2022. This represents a \$67 million or 8.2 percent increase

over current spending in this area. The proposal also indicates that another \$9 million from the ARP would be designated to support COVID-19 efforts in the Medical and Prosthetic Research Plan.

#### THE ADMINISTRATION'S FY2022 BUDGET PROPOSAL: OTHER AGENCIES

The President's budget highlighted several programs and initiatives important to people with disabilities. These included:

Within the Department of Education:

• 3.7 billion for state vocational rehabilitation agencies, client assistance programs, and protection and advocacy programs.

Within the Department of Health and Human Services:

• \$148.2 million for the Independent Living Program within the Administration for Community Living.

Within the Department of Housing and Urban Development:

- \$4 million for the Veterans Housing Rehabilitation and Modification Pilot Program to rehabilitate and modify the homes of disabled and low-income veterans.
- \$30.4 billion for the Housing Choice Voucher Program to accommodate 200,000 new vouchers.
- \$85 million for Fair Housing programs, and increased HUD staff capacity to redress discriminatory housing practices.

Within the Department of Justice:

 \$307.2 million would be devoted to civil rights efforts, an increase of \$177.2 million over FY 2021 and includes \$10,000,000 for a grant program for state and local law enforcement to provide officer training on responding to individuals with mental illness or disabilities and \$17,500,000 for education and training to end violence against and abuse of women with disabilities.

#### Within the Department of Labor:

- \$2 billion over six years to transition people with disabilities from subminimum wage jobs.
- \$42.7 million for the Office of Disability Employment Policy including \$9.8 million for research and development on effective ways to promote greater labor force participation by people with disabilities.
- \$180 million for the Veterans' Employment and Training Service for Jobs for Veterans State Grants, \$31 million for transition assistance programs, and \$57 million for homeless and at-risk veterans programs.

#### Within the Department of Transportation:

\$75,000,000 to bring Amtrak-served facilities and stations into compliance with Americans with Disabilities Act.

### **HOUSE T&I COMMITTEE MARK UP TRANSPORTATION BILL**

The INVEST in America Act, which passed the House Transportation and Infrastructure Committee by a vote of 38-26, is a five-year, \$547 billion surface transportation reauthorization bill that directs federal investments in roads, bridges, transit, and rail. Among other provisions, it creates new programs to address several pressing transit challenges—improving compliance with the Americans with Disabilities Act (ADA) and addressing transit deserts by providing expanded transit service to unserved and underserved communities. It also triples funding for Amtrak to \$32 billion, allowing for enhanced service, ADA upgrades, and investments to renew and support service on the Northeast Corridor and longdistance and state-supported routes. Additionally, it creates a pilot to improve flexibility in paratransit trips, allowing for brief stops such as childcare pick-ups and drop-offs, and short trips to the grocery store, pharmacy, or bank. The legislation will now be considered on the House floor.

### CMS REMINDS VETERANS AND CAREGIVERS ABOUT AFFORDABLE MARKETPLACE HEALTH INSURANCE **PLANS**

The Centers for Medicare and Medicaid Services (CMS) is highlighting provisions of the American Rescue Plan (ARP) that offer people an opportunity to enroll in Affordable Care Act (ACA) marketplace health insurance plans. The ARP, which passed earlier this year, contains a special enrollment period for health plans under the ACA. While most PVA members have access to the VA health care system, many other veterans, as well as caregivers, struggle to find affordable health insurance coverage.

#### Under the law:

- More people will qualify for tax credits that lower the cost of health coverage, even those who were not eligible in the past.
- Most people currently enrolled in a Marketplace plan will qualify for more tax credits.
- Health insurance premiums after these new savings will go down.
- Four out of five customers can find a plan for \$10 or less per month.

People interested in finding out more about the Special Enrollment Period or in applying for coverage can go to HealthCare.gov (or CuidadoDeSalud.gov for Spanish speakers) by August 15, 2021. Individuals who submit applications will have 30 days to enroll in a plan. Coverage starts the first day of the month after enrollment. For example, if someone enrolls any time in May, coverage starts June 1. More information is available here.

#### **NEWS ITEMS OF NOTE**

PVA Raises ADA Issues to Department of Justice's, Disability Rights Section

Through our work with the Consortium for Citizens with Disabilities Rights Task Force, PVA recently had the opportunity to meet with staff for the Disability Rights Section

of the Department of Justice regarding a variety of issues of interest to the disability community. During the meeting, PVA staff specifically expressed the need for renewed enforcement of disability civil rights laws, including the Americans with Disabilities Act (ADA) and for regulations governing standards for equipment and furniture under the ADA. In 2017, the Department withdrew pending regulatory action on web access, next generation 911, and accessibility of equipment and furniture, including medical equipment and hotel beds. DOJ officials noted that the Department had recently filed a Statement of Interest in a case pending against Aimbridge Hospitality regarding bed height. The Statement of Interest clarified that where an alleged barrier the height of a hotel bed—is not addressed by the ADA Standards, the ADA's general nondiscrimination provisions still apply, including making reasonable modifications where necessary to provide goods and services to people with disabilities. Disability Employment Incentive Act, H.R.
 3765, Introduced in House

On June 8, Rep. Josh Harder (D-CA) and Rep. Brian Fitzpatrick (R-PA) introduced H.R. 3765, the Disability Employment Incentive Act. This is the House companion to S. 630 sponsored by Sen. Bob Casey (D-PA). The measure expands the populations covered by the Work Opportunity Tax Credit to include persons receiving Social Security Disability Insurance and makes long overdue increases in the Accessibility Tax Credit and Architectural Barrier Removal Tax Deduction that can help businesses with pre-1990 buildings upgrade their facilities. • Senate Bill on Paratransit Introduced

On June 10, Sen. Bob Menendez (D-NJ), introduced legislation to increase accessible transportation for people with disabilities

(S.2038). This is the companion piece to H.R. 1697 introduced by Rep. Jim Langevin (D-RI). The bill establishes a pilot program for one-stop para-transit services. This would provide transport for eligible recipients to child care and education facilities, banks or ATM stations, pharmacies and or grocery stores.
